

## OHA-PAC Fundraising Talking Points

**Why contribute to OHA-PAC:** Participation in the political process via an OHA-PAC contribution is not just a necessary activity, it is also a good business decision for hospitals. It remains a key and practical way to help lawmakers who have stood with us on difficult votes:

1. Legislators who have stepped up and actively supported revenue raising bills and bills to stop the outsourcing of Medicaid to out-of-state insurance companies.
  - a. (71 voted yes on recent tax bill)
2. Candidates running in open seats who support OHA initiatives.

OHA's 2018 legislative agenda includes renewed efforts to raise the cigarette tax by \$1.50 per pack dedicated to fund health care. OHA also supports revenue measures that are vital to fund core government services. Health care is competing with:

- Lobbyists for “big tobacco” who are very busy trying to hold a small number of votes to “NO” to keep the Oklahoma House from reaching the required 76 votes to raise the cigarette tax and other vital tax measures.
- Lobbyists paid by out-of-state insurance companies who are making large campaign contributions to lawmakers to gain support for “outsourcing the Medicaid program.”

**Please make OHA-PAC a priority in the upcoming year:** Hospital CEOs who experience successful campaigns agree that it all starts with “the ask.” You may solicit contributions from a corporation’s directors, executive, administrative personnel, shareholders and their families.

- Executive and administrative personnel include individuals who are paid a salary (not on an hourly basis) and who have policymaking, managerial, professional or supervisory responsibilities.
- Be sure to ask those in your hospital who have given in the past. Make a special appeal to those who have not given – perhaps ask for smaller donations to begin a pattern of giving!

### **SAVE THE DATE:**

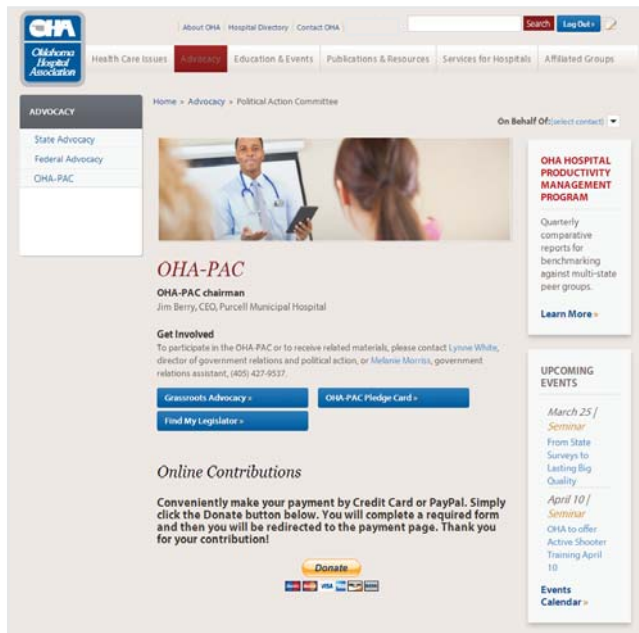
