Update on Ligature Risks and Suicide Prevention (IA0217)

Hospitals must comply with CMS' conditions of participation. According to CMS and accrediting organizations such as Det Norske Veritas (DNV) and The Joint Commission (TJC), one of the most-cited deficiencies at the immediate-jeopardy level is the right of patients to receive care in safe settings. Ligature risks compromise patients' rights to receive care in safe settings. A hospital's responsibility to provide care and safety to psychiatric patients at risk of harm to themselves or others is a primary concern

Access to affordable, safe, stable housing is a well-documented social determinant of health. The critical shortage of affordable housing nationally directly affects patients and providers, hindering health outcomes and contributing to repeat emergency room visits and hospital admissions. As providers continue to advance mission- and value-based care strategies, housing can be a high-impact component of those strategies. But, like health care, the housing industry operates with unique regulations, capital structures and business standards that warrant consideration as providers begin to explore potential housing strategies and investments. This session will explore potential housing investment strategies for health care providers, including initial business and legal considerations.

The Intersection of DEA, Opioids & Hospital Risk (LA022222)

Target Audience: COO, CMO, CNO, nursing, pharmacy, compliance, medical staff coordinators, regulatory, safety, quality, risk, legal counsel.

Speaker: Dennis A. Wichern, partner, Prescription Drug Consulting

During 2021, hospitals were fined almost \$14 million by the DEA for improper handling and prescribing of controlled substances. As a result of the ongoing opioid epidemic, hospitals have been added to the government's continued focus on prescription opioids. This webinar will connect the DEA's specific authorities in the practice of medicine and controlled substances, considering the opioid epidemic, and how it specifically relates to hospital and medical clinics. Through a review of federal law and actual case studies involving several hospital investigations, attendees will learn

what triggers a DEA investigation, how to respond, and how to prevent one from ever happening at their hospitals.

This webinar is a data driven, common sense review of recurring problem areas and red flags from a former DEA agent with real life prescription opioid experience. Updates regarding new federal law pharmacy requirements for “suspicious order monitoring”, DEA’s registration, controlled substances security requirements and emerging best practices tips will be included.

- Describe the DEA’s specific authorities and role in relation to controlled substances, hospitals, and the practice of medicine.
- Articulate characteristics and red flags that are often seen in hospitals that result in monetary fines.
- Discuss practical strategies and tips to reduce opioid risk at medical organizations while complying with federal law.
